No cover provided in respect of Ring Wrestling Events/Shows.

Including all Official IBF/BCSA/Pankration UK/ British Grappling Association run Events & Tournaments.

All Tournaments & Competitions to be run strictly in accordance with IBF/BCSA/Pankration/British Grappling Association Rules, with recognized protective clothing to be worn.

All Accidents & Injuries are to be Recorded, failure to do so could invalidate policy cover.

All instructors must hold a coaching /Instructors award recognized by the IBF/BCSA/Pankration UK/British Grappling Association and must be approved as an instructor by the IBF/BCSA/Pankration UK/British Grappling Association.

Cross Training in other sports will be covered if undertaken under the direction of an IBF/BCSA/Pankration UK/British Grappling Association Coach and within a supervised safe environment.

Only those members and Coaches recorded by the IBF/BCSA/Pankration UK/ British Grappling Association and lodged with the insurers agent will be covered by the policy.

For payment of an additional premium, Commercial Coaches can coach non members and for a fee.

Coaches failing to register all members of their classes will invalidate the policy cover provided. Coaches must record details of all attendees at each class.
